Opioid Treatment Program for Low-income Young Adults Hayley Feuer (Graduate student),2021 Abstract: The purpose of this project was to develop an opioid treatment program, identify potential funding sources, and write a grant application for the Los Angeles Centers for Alcohol and Drug Abuse (LACADA) in downtown Los Angeles. Findings from the literature review indicated that mental health disorders, age, history of a substance use disorder (SUD), gender, poverty, unemployment, and education level were the risk factors most commonly associated with opioid use disorder (OUD).
